Teaser	Do you commercially control vertebrate animals as pests? Then you need an animal welfare permit from the competent authority.
Volltext	If you wish to control vertebrate animals as pests on a commercial basis, you will require a permit under animal welfare law from the competent authority before commencing your activity. In order to obtain a permit, you may also need to enclose certificates of competence from persons who regularly stun or kill vertebrates for the purpose of killing them on a professional or commercial basis with your application. You may commence the activity as soon as you have been granted the permit.
