Teaser	You can have your residence permit for the purpose of school-based vocational training extended before it expires if you wish to continue your school-based vocational training in Germany.
Volltext	<p>The residence permit for the purpose of school-based vocational training is a temporary residence permit. You can apply to extend your residence permit if you wish to continue your vocational training beyond the period of validity of your residence permit.</p> <p>Apply for an extension of your residence permit at least eight weeks before the expiry date at the immigration office responsible for your place of residence.</p> <p>The same conditions apply to the extension of the residence permit for the purpose of school-based vocational training as to the granting of the permit.</p> <p>If your residence permit is extended, it will be limited in time again. The residence permit for the purpose of school-based vocational training will be extended for the duration of the training.</p> <p>As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.</p>

## Sachverhalt

- Proof of livelihood (e.g. blocked account at a German bank or declaration of commitment)
- Proof of apprenticeship
- Current biometric photo
- Tenancy agreement
- Proof of your health insurance

## Voraussetzungen

- You have a recognized and valid passport or passport substitute and a valid residence permit for the purpose of school-based vocational training in accordance with Section 16a (2) of the Residence Act.
- Your residence permit will expire in the near future.
- There is no interest in deporting you.
- Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.
- Your livelihood is secured for the duration of your vocational training.
- You have a training place in Germany that leads to a state-recognized vocational qualification in accordance with federal or state regulations.

## Kosten

- Extension of the residence permit for the purpose of school-based vocational training:
  - for a further stay of up to three months: EUR 96
  - for a further stay of more than three months: EUR 93
- Under certain conditions, a fee reduction or fee exemption may be possible

## Verfahrensablauf

You must apply for an extension of your residence permit at the foreigners authority responsible for your place of residence.

- Depending on the foreigners authority and your request, it may be possible to apply online. Find out whether your foreigners authority offers electronic application for a residence permit.
- If the application can only be made in person, arrange an appointment with the immigration office.
- During the appointment, your application will be accepted and your supporting documents checked (please bring these with you to the appointment). Your fingerprints will be taken to issue the electronic residence permit (eAT).
