Teaser	Once your foreign professional qualification has been recognized, you can immediately be granted a residence permit to take up employment or self-employment for a maximum of 12 months.
Volltext	If the equivalence of your foreign professional qualification has been established or you have been granted permission to practise your profession, you can be issued a temporary residence permit to look for a job or take up self-employment directly following your previous recognition procedure. This residence permit allows you to work without restriction.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid national passport</li> <li>• Proof of secure means of subsistence (e.g. employment contract and payslips, bank statements, declaration of commitment by a third party)</li> <li>• Proof of health insurance</li> <li>• Proof of qualification (diploma, certificate or certificate from your training company or educational institution confirming successful completion of training)</li> <li>• 1 current biometric photo</li> <li>• Please ask your local immigration office whether you</li> </ul>

Voraussetzungen	<p>You already have a residence permit for the purpose of the recognition procedure of a foreign professional qualification in Germany.</p> <p>The other general requirements for obtaining a residence permit are, in particular</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• possession of a valid national passport.</li> </ul>
Kosten	Gebühr: 98€
Verfahrensablauf	<p>You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You must submit the required documents in the original and pay the application fee.</li> <li>• The Foreigners' Registration Office will check whether the requirements for issuing the permit have been met.</li> <li>• If all requirements are met, the foreigners authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH.</li> <li>• As soon as the eAT is ready, it will be issued to you by the Foreigners' Registration Office.</li> </ul>
Bearbeitungsdauer	The processing time depends on the workload at the local foreigners authority.
Frist	Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires. The residence permit is limited to a maximum of 12 months.
