	A residence permit is a residence title. The residence permit can only be issued for a specific purpose, such as taking up self-employment.
Erforderliche Unterlagen	 Valid national passport Proof of health insurance; Tenancy agreement Curriculum vitae and proof of qualifications for previous activities and training (diplomas, certificates or attestations) Financing plan / business plan 1 current biometric photo Please ask your local immigration office whether you need to submit any other documents.
Voraussetzungen	You can only be granted a residence permit if
	 there is an economic interest or a regional need for the activity and the activity is expected to have a positive impact on

	the economy in Germany and • the financing of the implementation is secured by equity capital or a loan commitment.
	If you have already reached the age of 45, an appropriate pension plan is also required.
	Furthermore, the general requirements for obtaining a residence permit must be met.
	These are in particular
	a secure livelihood,a clarified identity,possession of a valid national passport.
Kosten	Gebühr: 100€
Verfahrensablauf	You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence.
	 You must submit the required documents in the original and pay the application fee. The foreigners authority will check whether the conditions for issuing the permit are met. If necessary, other authorities will be involved. If all requirements are met, the immigration authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH. As soon as the eAT is ready, it will be issued to you by the immigration authority.
Bearbeitungsdauer	The processing time depends on the workload at the local Foreigners' Registration Office.
Frist	Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires. The residence permit is issued for a maximum of 3 years.
