Teaser	If you are likely to be permanently accommodated in a hospital, nursing home or similar facility, you can be exempted from the obligation to have an ID card. The application can also be submitted by a representative. For a resident, you as a caregiver can arrange for the exemption from the ID requirement.
Volltext	If you are likely to be permanently accommodated in a hospital, nursing home or similar facility, you may be exempt from the obligation to have an ID card. This is the case, for example, if you are no longer able to live in your home due to your state of health.

Voraussetzungen	• You must have German citizenship. • You must be at least 16 years old. • You are likely to be permanently accommodated in a hospital, nursing home or similar facility. • You must be registered as having your main residence in your municipality/city.
Kosten	There are no costs.
Verfahrensablauf	You must apply in writing for exemption from the ID card requirement. • You or a person representing you must submit an informal application or complete an application form for exemption from the ID card requirement from your local ID card authority • You or a person representing you sign the application. • You enclose the necessary documents (see "What documents are required?"). • You send the application and the documents to the relevant ID card authority in your municipality/city or • You or the person representing you go to the relevant authority in person. • The authority will issue you with a permanent certificate stating that you are exempt from the ID card requirement.
