Teaser	<p>If you want to run a private school as an alternative school, you can receive state recognition under certain conditions and thus participate in state private school funding.</p> <p>In some federal states, state recognition gives alternative schools the right to hold examinations and issue certificates such as the Abitur itself.</p>
Volltext	<p>As a private provider of alternative schools can apply for state recognition once they have been granted approval to operate the school and, as a rule, have successfully run the course for three years. Verfahrensablauf	As the provider of the alternative school, you must first apply for approval of your institution. You must then operate the course successfully for three years. You

	then submit the application for recognition to the responsible authority.
Bearbeitungsdauer	If all recognition requirements are met, processing takes between 3 and 6 months.
Frist	Recognition of an alternative school is only granted at the beginning of the school year (August 1 of each year); you must submit the application for recognition at least three months in advance. at the latest.
