Teaser	If you need to present a German death certificate in another EU country, you can apply for a multilingual form to be issued by the registry office.
Volltext	If you have to present a German death certificate in another country of the European Union, you can apply for a multilingual form to be issued by the registry office. The form replaces the translation of the German death certificate that is generally required.
Erforderliche Unterlagen	• Death certificate, • official photo ID as proof of identity (copy), e.g. identity card or passport.
Voraussetzungen	You are entitled to apply for the issue of a multilingual death certificate form as: • Spouse and partner of the deceased person, • ancestor and descendant of the deceased person (e.g. child, grandchild), • siblings of the deceased person, if you can credibly demonstrate a legitimate interest, or • another person if you can credibly demonstrate a legal interest.

	You must be at least 16 years old.
Kosten	Gebühr: 13€ for one copy Gebühr: 6,50€ from the second copy
Verfahrensablauf	You submit the application for a multilingual form for a German death certificate verbally or in writing to the relevant registry office. • You submit the application for a multilingual form for a German death certificate to the relevant registry office and enclose the required documents. • In order for a multilingual form to be issued, you must specify the country in which the certificate is to be presented. • The registry office will check your details and the documents you have submitted and, if necessary, issue the multilingual form. • The registry office will send you the multilingual form by post if no personal collection has been agreed. • The fees are paid either in advance or after sending / on collection. You can also apply for the issue of a multilingual form in connection with the issue of a death certificate.
Bearbeitungsdauer	The processing time may vary.
Frist	The 30-year period for keeping the register of deaths by the registry office must not have expired.
