Teaser	Before you can apply for a falconer hunting license, you must pass a falconer examination in addition to the (special) hunter examination.
Volltext	If you want to practice pickling in Germany, you need a falconry hunting license in your name. To apply for a falconer hunting license for the first time, you need to pass a falconer examination. Another requirement is that you have passed the hunter's examination or a special hunter's examination for falconers. You apply for admission to the falconer examination at the authority that carries out a falconer examination (not all authorities carry out a falconer examination).
