Teaser	Are you a driver of a truck or bus and your driver card is about to expire? Then you can have it renewed.
Volltext	The driver card is used to record driving times and rest periods for the commercial transportation of goods and passengers. The driver card is valid for 5 years from the date of issue. You can have the driver card renewed on application. You must do this at least 15 working days before the card expires. If your driver card has already expired, you must place a new initial order. Your renewed driver card is valid immediately after the expiration date of the old card. You must carry the expired driver card for at least 28 days in addition to the new card. Only you may use the driver card issued to you personally. It always remains your property, even if your employer has paid for the driver card. In principle, they are not obliged to cover the costs.

Voraussetzungen	• You are resident in the Federal Republic of Germany. • You have a valid driver's license with one of the following categories: B, BE, C1, C1E, C, CE, D1, D1E, D, DE. • Your valid driver's license must correspond to one of the above categories if it was issued in an EEA member state.

Kurztext	• Driver card renewal • Bus drivers and truck drivers in commercial road transport require a valid driver card • Applying for a new driver card: You already have a driver card that is due to expire • Driver card is valid for 5 years • Deadline: New driver card may be applied for no earlier than 6 months and must be applied for no later than 15 days before the old card expires • If the driver card has already expired, a new initial order must be made • the expired driver card must be carried for at least 28 days in addition to the new card • Responsible: different authorities depending on the federal state, e.g. driving license authority, TÜV, Dekra or others
