Teaser	Have you accidentally discovered groundwater while drilling? Then you must inform the competent authority, regardless of whether you reported the well in advance or not.
Volltext	If you accidentally hit groundwater while drilling, you must report this to the competent authority immediately. The notification is necessary in any case, regardless of whether the drilling was previously reported to the competent authority or not. The authority will inform you whether you may have to temporarily stop drilling.
