Teaser	If the validity of your youth hunting licence expires or has already expired and you wish to continue hunting, you must have it extended.
Volltext	If you want to hunt in Germany, but you are not yet 18 years old, you can only be issued a youth hunting license in your name. If you already have a hunting licence whose validity has expired, you can apply for an extension.
Erforderliche Unterlagen	• Shooting licence • if applicable, current photograph • Proof of statutory hunting liability insurance • Consent of the person with custody
Voraussetzungen	• at least 16 and not yet 18 years old • personal reliability • physical fitness • Hunting liability insurance • already issued youth hunting license • Consent of the legal guardian

	available, online. If you submit the application in writing, fill it in and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a youth hunting license.
Bearbeitungsdauer	
Frist	The day hunting licence is valid for 14 consecutive days.

Hinweise	The youth hunting licence entitles the holder to hunt only in the company of a person with custody or a supervisor appointed in writing by the person with custody; the accompanying person must be experienced in hunting. The youth hunting license does not entitle the holder to participate in group hunts.

Kurztext	• Youth hunting licence Re-issue of day hunting licence • required for hunting in Germany • Persons who already hold or have held a German hunting license • if validity has expired or expires, then the hunting licence must be renewed if hunting is to continue • for persons under 18 years, minimum age 16 years • Accompaniment by experienced hunting guardians or representatives required • no participation in party hunting • is valid for 14 consecutive days • responsible: lower hunting authority
