Teaser	If you want to hunt in Germany as a young foreigner and you have not passed a German hunter's exam, you must carry a foreigner's youth hunting license in your name.
Volltext	If you would like to hunt in Germany as a foreign citizen, but you are not yet 18 years old, you can only be issued a foreigner's youth hunting licence in your name. If you do not provide proof of a German hunter's examination, you can apply for a youth annual hunting licence for foreigners under certain conditions.
Erforderliche Unterlagen	 Identity card Hunting license of the home country if applicable, certificate of the hunter's examination with any additional documents current photograph Proof of statutory hunting liability insurance Consent of the person with custody

Verfahrensablauf	You can submit the application in writing or, if available, online.
	If you submit the application in writing, fill it out and submit it by post or in person to the competent authority.
	The application and the evidence to be provided will be checked for completeness and correctness.
	If you meet all the requirements, you will be issued a foreigner youth hunting license.
Bearbeitungsdauer	
Frist	The annual hunting licence is valid for a maximum of two consecutive hunting years. The hunting year begins on 01/04 and ends on 31/03.
weiterführende Informationen	
Hinweise	With a youth hunting license, you may only hunt if accompanied by a legal guardian who is experienced in hunting or a supervisor with hunting experience who has been commissioned in writing by your legal guardian(s).
	Upon request, the youth hunting licence must be presented to the persons entitled to hunt protection and police officers.
	With a youth hunting license, you are not allowed to participate in group hunts.

Kurztext	 Foreigner Youth Hunting Licence Issuance of annual hunting licence required for hunting in Germany for non-German citizens who have passed an examination comparable to the German hunter's examination The prerequisite is that you do not have your main residence in Germany Proof of suitability for proper hunting must be provided by presenting a hunting license issued in the last three years for persons who are at least 16 and under 18 years old is valid for a maximum of 2 consecutive years Accompaniment by a legal guardian or representative with hunting experience required no participation in community hunting is issued by the authority in whose area of responsibility the hunt is to be carried out predominantly responsible: lower hunting authority
Ansprechpunkt	You can apply for the youth annual hunting licence for foreigners at the lower hunting authority in whose area of responsibility you would like to hunt for the most part.
Zuständige Stelle	The responsibility is incumbent on the lower hunting authority.
