Volltext	If you want to hunt in Germany, you need a German hunting license in your name. If your day hunting licence for foreign young people has been revoked, you can apply for it again at the authority that revoked your hunting licence after the specified blocking period has expired.

Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue • personal reliability • Physical aptitude • Hunting liability insurance • already issued youth hunting license withdrawn • Consent of legal guardians • elapsed embargo period

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, fill it out and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a foreigner youth hunting license.

Frist	The day hunting license is valid for 14 consecutive days.
