Volltext	If you want to hunt in Germany, you need a German hunting license in your name. If your annual hunting licence for foreign young people has been revoked, you can apply for it again at the authority that revoked your hunting licence after the specified blocking period has expired.

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, fill it out and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a foreigner youth hunting license.

Frist	The annual hunting licence is valid for a maximum of three consecutive hunting years. The hunting year begins on 01/04 and ends on 31/03.
