Kurztext	• Foreigner falconer hunting licence change • required for pickling hunting in Germany • Changes of name and place of residence must be entered • is amended by the authority that issued the falconry licence • if you are resident in Germany, the local authority is responsible • responsible: lower hunting authority
Ansprechpunkt	You have the change made by the authority that issued the hunting license. On the other hand, if you have moved your main residence from abroad to Germany, you must contact the authority responsible for the new place of residence.
