Teaser	If you want to build, operate or make certain modifications to a Category IV steam boiler plant, you must apply for a permit from the competent authority.
Volltext	<p>Steam boiler systems of the so-called category IV are heated pressure equipment at risk of overheating for the production of steam or hot water with a temperature of more than 110 degrees Celsius. These are systems that need to be monitored.</p> <p>You will need a permit from the relevant authority if you are using a Category IV steam boiler installation.</p> <ul style="list-style-type: none"> <li>• want to build and put into operation, or</li> <li>• want to change the design or mode of operation in such a way that the safety of the system is affected.</li> </ul> <p>Permission can be granted to you subject to the following restrictions:</p> <ul style="list-style-type: none"> <li>• limited</li> <li>• temporary</li> <li>• under conditions, or</li> <li>• with conditions.</li> </ul> <p>If the installation requiring a permit is part of an installation requiring a permit, no separate permit will</p>

	<ul style="list-style-type: none"> <li>• They must construct and operate state-of-the-art steam boiler systems.</li> <li>• Your documentation must be complete, plausible and meaningful.</li> <li>• The test report of the approved inspection body (ZÜS) must confirm that the requested installation can be operated safely if the measures specified in the documents, including the tests, are complied with.</li> </ul>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• Submit the application for permission for the installation requiring monitoring to the competent authority with the necessary documents, including the test report of the approved inspection body (ZÜS).</li> <li>• If there is a permit requirement under the Federal Immission Control Act, you will receive the application documents back, as a permit under the Industrial Safety Ordinance will then be checked as part of the necessary permit under the Federal Immission Control Act.</li> <li>• The competent authority shall take its decision after examination and shall inform you thereof.</li> </ul>
Bearbeitungsdauer	<p>0 - 3 Monat(e)</p> <p>The processing time applies from the date of receipt of the complete application documents. An extension of the processing period is possible in justified cases.</p>
Frist	<p>The permit expires if:</p> <ul style="list-style-type: none"> <li>• you have not started the construction of the installation within two years of the permit being granted,</li> <li>• you have interrupted the construction of the installation for two years or more,</li> <li>or • You have not operated the system for a period of three years. For important reasons, you can apply to the licensing authority for an extension of the deadlines.</li> </ul>

Kurztext	<ul style="list-style-type: none"> <li>• Construction and operation of a plant requiring monitoring in accordance with the Industrial Safety Ordinance Approval of steam boiler systems</li> <li>• Anyone wishing to construct or operate a category IV steam boiler system or to make changes to the design or mode of operation requires a permit.</li> <li>• Category IV steam boiler installations include heated pressure equipment at risk of overheating for the production of steam or hot water at a temperature of more than 110 degrees Celsius.</li> <li>• These are "systems requiring monitoring" that must be assembled, installed and operated according to the state of the art.</li> <li>• The permit can: granted subject to conditions, limited for a limited period of time and be subject to</li> </ul>
