Teaser	If you want to establish, operate or make certain changes to a storage facility, you must apply for a permit from the competent authority.
Volltext	Storage facilities are rooms or areas, including the fixed containers and other storage facilities provided for in them, which are used for the storage of flammable liquids with a total volume of more than 10,000 litres. They are systems that need to be monitored.
	You will need permission from the competent authority if you:
	<ul> <li>want to build and operate a storage facility</li> <li>want to make changes to the design or operation that affect the safety of the installation.</li> </ul>
	Permission can be granted to you subject to the following restrictions:
	<ul> <li>limited</li> <li>temporary</li> <li>under conditions, or</li> <li>with conditions.</li> </ul>

	If the installation requiring a permit is part of an installation requiring a permit, no separate permit will be issued. The permit includes the permission.

	<ul> <li>file number and details of the approval authority of a building permit that has already been granted, or</li> <li>to the approval authority in the case of a building permit that has yet to be applied for or has already been applied for</li> </ul>
Voraussetzungen	• The plant for which you are applying for the permit must be an installation requiring a permit.

	<ul> <li>They must construct and operate state-of-the-art storage facilities.</li> <li>Your documentation must be complete, plausible and meaningful.</li> <li>The test report of the approved inspection body (ZÜS) must confirm that the requested installation can be operated safely if the measures specified in the documents, including the tests, are complied with.</li> </ul>

Verfahrensablauf	<ul> <li>Submit the application for permission for the installation requiring monitoring to the competent authority with the necessary documents, including the test report of the approved inspection body (ZÜS).</li> <li>If there is a permit requirement under the Federal Immission Control Act, you will receive the application documents back, as a permit under the Industrial Safety Ordinance will then be checked as part of the necessary permit under the Federal Immission Control Act.</li> <li>The competent authority shall take its decision after examination and shall inform you thereof.</li> </ul>
Bearbeitungsdauer	0 - 3 Monat(e) The processing time applies from the date of receipt of the complete application documents. An extension of the processing time is possible in justified cases.
Frist	The permit expires if: • you have not started the construction of the installation within two years of the permit being granted, • you have interrupted the construction of the installation for two years or more, or • You have not operated the system for a period of two years. For important reasons, you can apply to the licensing authority for an extension of the deadlines.

	<ul> <li>You may appeal against the decision within one month of notification.</li> <li>You must submit the objection to the competent authority in writing or for a record.</li> </ul>
	<ul> <li>In Rhineland-Palatinate, objections can also be filed in electronic form.</li> </ul>
Kurztext	<ul> <li>Construction and operation of a facility requiring monitoring in accordance with the Industrial Safety Ordinance Approval of storage facilities</li> <li>A storage facility is used to store flammable liquids with a total volume of more than 10,000 liters</li> <li>Storage facilities are "facilities requiring monitoring"</li> <li>They must be assembled, installed and operated according to the state of the art</li> <li>Anyone wishing to build or operate a storage facility or to make changes to the design and operation of it requires a permit</li> <li>The permit can: granted subject to conditions, limited for a limited period of time and be subject to conditions.</li> <li>Application: informally in writing or electronically</li> <li>Application for partial licence is possible</li> <li>Required documents, including: Subject matter of the application Description of the plant Description of the plant technology and interaction with other plants Piping and instrumentation diagram (P&amp;ID diagram) Test report of an approved inspection body (ZÜS)</li> <li>responsible: Occupational health and safety authority or trade supervisory authority</li> </ul>
