Volltext	If you want to practice pickling hunting in Germany, you need a German falconer hunting license in your name. If your day hunting license for foreign falconers has been revoked, you can apply for it again after the established blocking period has expired.
Erforderliche Unterlagen	• If applicable, current photograph • Proof of statutory hunting liability insurance
Voraussetzungen	• at least 18 years old at the time of issuance • personal reliability • Physical aptitude • Hunting liability insurance • falconry licence that had already been issued was revoked • elapsed embargo period
Kosten	Verwaltungsgebühr: 17€ With the fee for the issuance or renewal of the hunting license, a hunting fee of five times the amount of the fee is charged.

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, fill it out and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a foreigner falconer hunting license.
