Teaser	Would you like to work in Germany as an apprentice farrier? Then you need state recognition. In particular, you must have your foreign professional qualification recognized as equivalent to the German qualification.
Volltext	<p>The profession of farriery apprentice is regulated in Germany. This means that you need state recognition in order to work as an apprentice farrier in Germany. You can also obtain state recognition with a professional qualification from abroad.</p> <p>In the recognition procedure, the competent authority compares your professional qualification from abroad with the German professional qualification and checks the equivalence of the two qualifications.</p> <p>In addition to the equivalence of the professional qualification, you must also meet other requirements for state recognition. In particular, you must provide</p>

evidence of professional experience, regular further training and knowledge of vocational and occupational education. To do this, you must already have state recognition as a farrier. You must also provide evidence of at least 5 years of professional experience in the profession and attendance at the required further training courses.

You must also prove that you are reliable enough to work as a farrier's apprentice.  
 You can also apply for the procedure from abroad.

## Erforderliche Unterlagen

- Proof of identity (identity card or passport)
  - Marriage certificate (if your name has changed due to marriage)
- Curriculum vitae
- Proof of your professional qualifications (e.g. certificates, professional certificate)
  - Proof of state recognition as a farrier
  - Proof of training (e.g. location, duration and content of training)
- Proof of your relevant professional experience as a farrier
  - Proof of other relevant knowledge, skills and abilities (e.g. attendance of further training events, proof of vocational and occupational pedagogical knowledge)
- Have you already submitted an application for recognition? If so, please state the body to which you submitted the application.
- Proof of personal suitability: official certificate of good conduct from Germany. Or: Confirmation from the country of training that you have not violated animal welfare laws.
- Are you from a third country and do not yet live or work in the EU, EEA or Switzerland? Then you must provide proof: You want to work in the profession in Germany. Proof can be, for example, applications for a job, invitations to job interviews or a location note from the Central Service Center for Professional Recognition (ZSBA).

If your documents are not in German, you must submit German translations of your documents. The

	translations must be made by translators who are publicly appointed or authorized.
Voraussetzungen	<ul style="list-style-type: none"> <li>• Your professional qualification is equivalent to the German professional qualification as a farrier's apprentice farrier.</li> <li>• You have state recognition as a farrier in Germany.</li> <li>• You have at least 5 years of professional experience as a farrier.</li> <li>• You have taken part in the required annual training courses.</li> <li>• You have the necessary knowledge of vocational education and work pedagogy.</li> <li>• Personal suitability: You are reliable to work as a farriery instructor and have not violated animal welfare regulations.</li> </ul>
Kosten	<p>The costs generally depend on the time and effort required for processing.</p> <p>Additional costs may also be incurred (e.g. for translations or notarizations). These costs vary from case to case.</p>
Verfahrensablauf	<p><b>**Application**</b></p> <p>You submit an application for state recognition as a farriery instructor to the competent authority. To do this, you must already have state recognition as a farrier in Germany.</p> <p>The competent authority will then check whether your training corresponds to the German training and whether all other requirements have been met. State recognition can only be granted if your training is equivalent to the German training.</p> <p><b>**Equivalent examination certificates**</b></p> <p>Some examination certificates (qualifications) from abroad are equated with the examination to become a farrier's apprentice farrier without an individual equivalence test. The equivalent examination certificates are listed in Annex 2 of the Farriery</p>

Recognition Ordinance.

### **\*\*Examination of equivalence\*\***

If your examination certificate is not automatically equated, the competent authority will compare your professional qualification with the German professional qualification. The competent authority will check whether your professional qualification is equivalent. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.

### **\*\*Possible results of the examination\*\***

If your professional qualification is equivalent, your foreign professional qualification will be recognized. The competent authority can confirm the result in writing. You must still meet the other requirements. You will then receive state recognition as an apprentice farrier.

Are there any significant differences between your professional qualification and the German professional qualification? You may be able to compensate for the differences through your professional experience, other knowledge, skills or abilities. You must provide evidence of your professional experience. Knowledge, skills and abilities must be certified by an authority in the country in which you acquired the knowledge or skills.

However, it may be that the significant differences cannot be compensated for by this knowledge, skills and abilities. In this case, your foreign professional qualification will not be recognized. You will then not be allowed to work as a farrier's apprentice in Germany.

However, the competent authority will tell you the main differences and why you cannot compensate for the main differences with your professional

experience. You can take a compensatory measure to make up for the substantial differences.

**\*\*Compensatory measures\*\***

There are various compensatory measures:

- Adaptation course: the adaptation course lasts a maximum of three years.
- Aptitude test: The aptitude test examines the areas in which significant differences have been identified.

You can choose between an adaptation period or an aptitude test. If you successfully complete the compensation measure and meet all other requirements, you will receive state recognition as an apprentice farrier.

## Bearbeitungsdauer

3 Monat(e)

The responsible office will confirm that your application and documents have been received after a maximum of one month. The competent office will inform you if any documents are missing. If the documents are complete, the procedure will take a maximum of 3 months. In justified cases, the deadline can be extended by one month.

Hinweise	<p><b>**Procedure for ethnic German repatriates**</b></p> <p>As a late repatriate, you can go through the recognition procedure either in accordance with the laws mentioned here or in accordance with the Federal Expellees Act. You can decide for yourself. The responsible office will advise you on which procedure is right for you.</p>
Rechtsbehelf	<p>You can take legal action against the decision of the competent authority within a certain period of time (for example, by lodging an objection). The decision will then be reviewed. Details can be found in the information on legal remedies at the end of your decision. We recommend that you first speak to the responsible office before taking legal action against the decision.</p>
Kurztext	<ul style="list-style-type: none"> <li>• Foreign professional qualification as a farrier's apprentice farrier Recognition <ul style="list-style-type: none"> <li>• To work as an apprentice farrier, you need state recognition in Germany.</li> <li>• You can also obtain state recognition in Germany with an equivalent professional qualification from abroad.</li> <li>• The competent authority checks whether the foreign professional qualification is equivalent to the German professional qualification as a farriery instructor.</li> <li>• Some examination certificates from abroad are treated as equivalent without an individual equivalence check. These are listed in Annex 2 of the Farriery Recognition Ordinance.</li> <li>• In addition to the professional qualification for the occupation, proof must be provided for state recognition in particular of vocational and occupational pedagogical qualifications and the necessary reliability for this activity.</li> <li>• The authority in the federal state in which the profession is to be practiced for the first time is responsible for checking equivalence and state recognition.</li> </ul> </li> </ul>
