Volltext	If you have an installation in accordance with the Industrial Emissions Directive you must submit an annual summary of the results of emission monitoring and other data to the competent authority to check compliance with the permit requirements. If an emission limit value, an emission level or an emission limit is determined above the emission bandwidths specified in the BAT conclusions, the summary of the results of the emission monitoring must allow a comparison with the emission bandwidths specified in the BAT conclusions. The annual summary of the emission monitoring results you do not need to submit if you have already submitted it to the competent authority under other legislation.
