Teaser	If you want to change a discharge from a small wastewater treatment plant for which you have a permit under water law, you must apply to the competent authority for a change of permit.
Volltext	If you want to discharge pre-treated wastewater from a small wastewater treatment plant into a body of water, you need a permit under water law.
	If you wish to change a project for which you have a permit under water law, you must apply to the competent authority for a change of permit.
	A small wastewater treatment plant is a wastewater treatment plant from which less than eight cubic meters per day of wastewater from households and similar wastewater is discharged.

	The wastewater from the small wastewater treatment plant can seep away or be discharged into an above-ground body of water.
	Surface waters are rivers, lakes, canals, streams, ditches and ponds.
	The permit specifies the type and extent of use. It may be subject to conditions and ancillary provisions. In contrast to a permit, a license can be revoked by the authorities.

Voraussetzungen	 The responsible authority has a permit for the project under water law. The requirements specified in the Wastewater Ordinance are complied with. The discharge is compatible with the requirements for water characteristics and other legal requirements.
Kosten	Gebühr: 265€ - 13.290€ High permission Gebühr: 36,10€ - 9.000€ Simple permission The fees stated apply to new permits.

Verfahrensablauf	 You can apply to your local water authority for an amendment to the permit to discharge pretreated wastewater from a small wastewater treatment plant into a body of water. The general procedure is as follows: Send your application for a permit change with the required documents to the responsible water authority. This checks that your application and documents are complete and contacts you if any information or documents are missing, examines your application from a water management and water law perspective and involves other authorities if necessary. You will receive a notice of amendment for the permit or a notice of rejection You will also receive a fee notice.
	• You pay the fee.
Bearbeitungsdauer	The processing time depends in particular on the quality and scope of your application and the documents.
Frist	There is no statutory deadline. Apply for the permit change well in advance of the planned change to the withdrawal.

	 A permit under water law is required for the discharge of pre-treated wastewater from a small wastewater treatment plant into a body of water. If a project for which a water permit has been granted is to be changed, an application must be made to the competent authority for a change of permit. The wastewater from the small wastewater treatment plant can be infiltrated or discharged into an above-ground body of water. Surface waters are rivers, lakes, canals, streams, ditches and ponds. Prerequisite: The requirements specified in the Wastewater Ordinance are complied with and the discharge is compatible with the requirements for water characteristics and other legal requirements.
