Teaser	You must notify the competent authority of groundwater abstraction for domestic use, farm operations, watering livestock or in small quantities for a temporary purpose.
Volltext	Groundwater abstraction for domestic use, farm operations, watering livestock or in small quantities for a temporary purpose does not require a permit under water law. It merely needs to be reported to the authorities in good time before it begins.
Erforderliche Unterlagen	<p>The documents you need for your application vary depending on the type and scope of your project. Voraussetzungen	<ul style="list-style-type: none"> • Groundwater and the public water supply are not endangered by your use. • This is the abstraction of groundwater for domestic use, farm use, watering livestock outside the farm or in small quantities for a temporary purpose. • the use of the water supply facilities for the household or farm is not prescribed by the water supply authority's statutes • a connection to the public water supply is not possible from an economic point of view
