	Submit the application to list your vocational school achievements to the relevant vocational school or the institution where you completed your retraining and enclose a copy of the proof of these achievements

	<ul> <li>Upon request:</li> <li>Duplicate of the certificate</li> <li>The certificate in English and French translation</li> <li>The vocational school achievements on the certificate</li> <li>Receipt of a written notification in the event of a failed examination</li> <li>Contains information on examination performance and on retaking the examination</li> <li>Responsible: usually the competent chamber</li> <li>Exception: otherwise determined by the state or federal government</li> <li>Exception: retraining has taken place under the responsibility of the public service or religious communities under public law</li> </ul>
Ansprechpunkt	Contact the chamber responsible for your vocational training. This can be
	<ul> <li>the Chamber of Industry and Commerce for vocational training in non-trade occupations,</li> <li>the Chamber of Skilled Crafts for vocational training in professions under the Crafts Code,</li> <li>the Chamber of Agriculture for vocational training in agricultural and rural domestic professions</li> <li>the Chamber of Lawyers, Patent Attorneys and Notaries as well as the Notary's Office for the vocational training of specialists in the field of law,</li> <li>the Chamber of Auditors and the Chamber of Tax Consultants for the vocational training of professionals in the field of auditing and tax consultancy,</li> <li>the Chambers of Physicians, Dentists, Veterinarians and Pharmacists for the vocational training of healthcare professionals.</li> </ul>
