Verfahrensablauf	Once you have submitted the application for recognition, the competent body will decide on this in a timely manner.
Bearbeitungsdauer	The processing time depends on the completeness and scope of the documents submitted. It can therefore vary individually.
Frist	Recognition can only be granted once all the necessary documents have been submitted and any outstanding issues have been clarified and the equivalence has been assessed. Deadlines are set by the pharmaceutical law does not set deadlines.

## Sachverhalt

- Only those who have the required expertise may work as a pharmaceutical consultant
  - This includes pharmacists, pharmacy assistants or pharmaceutical sales representatives, as well as persons with equivalent professional qualifications or degrees in the following areas
    - pharmacy,
    - chemistry
    - biology,
    - human or veterinary medicine
    - veterinary medicine
  - upon application, the competent authority may recognize as sufficient an examination or completed training that is at least equivalent to one of the training courses of the persons mentioned
  - Required documents:
    - signed curriculum vitae in tabular form on the professional career
    - all professional certificates obtained
    - Copy of the degree certificate or diploma
    - Document on the exact course and content of the training, including details of subjects and hours
    - If applicable, confirmation from the current or future employer with details of the place of work
    - Certificate of equivalence, if applicable, e.g. for professional qualifications obtained in third countries
    - The competent supervisory authorities of the federal states are responsible for recognition
