Volltext	<p>The register of vocational training relationships is kept by the bodies responsible for training.</p> <p>For example</p> <ul style="list-style-type: none"> <li>• Chamber of Industry and Commerce,</li> <li>• Chamber of Crafts,</li> <li>• other professional chambers.</li> </ul> <p>It contains all recognized training occupations and records all essential contents of the vocational training contract.</p> <p>If there are any changes after registration, you as the training provider can submit an application for a change to the competent regional authority. The competent authority will check the legality of the</p>

	<p>change and then confirm the change to the vocational training relationship.</p> <p>Changes can affect the following areas, for example</p> <ul style="list-style-type: none"> <li>• Changes to weekly working hours,</li> <li>• Change from full-time to part-time and vice versa,</li> <li>• change of specialization or change of address.</li> </ul>

Kosten	<p>Abgabe: 0€ - 100€</p> <p>The change may be subject to a fee for you as a training center. The fee is based on the respective fee regulations of the regional authorities responsible.</p>
Verfahrensablauf	<p>As the training provider, you submit the application for the change to the responsible office in analog or electronic form.</p> <p>The competent body will check the relevant data and documents in accordance with the Vocational Training Act and record them in the register of vocational training relationships.</p> <p>During the change, the training contract and training plan, for example, can be checked again with regard to</p>

	<p>the legal requirements, as well as the training center with regard to suitability for training.</p> <p>If necessary, the responsible office will contact you for the following reasons:</p> <ul style="list-style-type: none"> <li>• Queries</li> <li>• Additional requests for documents</li> <li>• Correction of deficiencies</li> </ul> <p>At the end of the procedure, you as the trainer will receive a corresponding notification from the competent body as to whether the change has been made or rejected.</p>
