The plan therefore shows how each part of the municipal area is to be used.</p> <p>Possible uses are</p> <ul style="list-style-type: none"> • Residential, • commercial, • transportation, • infrastructure, • recreation or • nature and the environment. <p>You can view new or recently amended land use plans on the Internet. If the responsible local authority does not yet provide the desired land use plan on the Internet, you have the right to view it at the local authority.</p> <p>The land use plan generally consists of:</p> <ul style="list-style-type: none"> • Indication of the planning objectives, • various maps on • land use, development or environment, • Legend to the maps and • Explanatory statement with, for example, an indication of the decisions and considerations.
