Volltext	<p>As a school authority, you are responsible for providing the equipment and materials for schools and for bearing the associated costs. This also includes school buildings and facilities.</p> <p>If you identify a need for new buildings, conversions and extensions to school buildings and the need to create the necessary school space with special consideration of educational needs is recognized, you can receive grants and subsidies from the state.</p>

This program is based on the school development plans and the number of pupils specified by the school authorities. It is also based on the schemes for determining the model space program. This program is based on the school development plans and the number of pupils specified by the school authorities. It is also based on the schemes for determining the model space program. The area program also takes into account the educational concept of your school and must be approved by the school authorities.</p> <p>You will not receive any grants for school building measures that only provide school space on a temporary basis or only for a transitional period. You will also not receive a grant for school construction measures that do not require a state grant - i.e. so-called minor cases. Building maintenance measures are also excluded from funding. Refurbishments are therefore your own responsibility as the school authority.carried out.</p>
