Teaser	Would you like to continue your bus company as an occasional service? Then you must apply for the necessary permit from the licensing authority responsible for you.
Volltext	You require a permit for the commercial transportation of passengers by bus or coach in occasional services. Occasional services include • Excursions • Vacation trips • Trips with rental buses The permit is limited to a maximum of 10 years. Before your temporary permit expires, you can submit a corresponding application for reissue to your competent licensing authority. On the basis of the new,
