Teaser	Are you unable to provide an upbringing that is in the child's best interests? Then you are entitled to educational assistance, which may take the form of home education.
Volltext	Crisis situations or family problems can lead to children or young people being placed in a home or other form of supervised living (e.g. supervised individual living, residential group for several young people, mother-child residential group). Home education or placement in another form of assisted living is possible: • as a temporary measure, after which the children or young people return to their family of origin • as a temporary measure that prepares the children or young people for placement in a foster family • as a permanent measure that prepares the children or young people for independent living
Erforderliche Unterlagen	Please clarify with the Youth Welfare Office which documents you need to submit.
Voraussetzungen	
Kosten	They must contribute to the costs of home education within their financial means.
Verfahrensablauf	As a guardian, please contact the responsible youth welfare office. It will assess your case and decide whether placing your child outside the family is a suitable measure. It will help you with the application
