Volltext	If you have been informed by cover letter that you have committed an administrative offence in road traffic, you will also be informed there that you can use the hearing. This gives you the opportunity to comment on the accusation and, for example, to refute the information provided by the authority. There is no obligation to use the consultation.
Erforderliche Unterlagen	- Hearing form- Alternatively: cover letter with the file number and the access code, if you want to use the hearing online
Voraussetzungen	- You are accused of an administrative offence in road traffic
Kosten	There are no costs.
Verfahrensablauf	• The competent authority will send you the notification that you have committed an administrative offence in road traffic. • In the letter you will be informed that you can comment on the allegation. • You can provide your details in writing on the hearing form or online. • If you wish to provide the information in writing, fill in the fields on the hearing form and then send it by post to the competent authority. • If you wish to provide the information online, follow the link provided in the letter and enter the access code mentioned in the letter. Then fill in the required

Kurztext	• Warnings and fines in road traffic Hearing • the hearing takes place before a warning or fine is issued • it can be carried out in writing or online • it can also take place on the occasion of a traffic control • in the case of a warning with warning money, the warning money notice is usually also the hearing sheet • if the offer of the shortened procedure is not accepted by payment of the warning fee and the period granted for this has expired, a fine procedure will be opened instead • if the opportunity of the hearing is not used in the fine proceedings or if the deadline is allowed to pass, a fine notice will be issued • responsible: respective regulatory authority
