Volltext	Dead animals such as farm animals, dead pets and certain waste of animal origin, such as slaughterhouse waste or food waste from restaurants or commercial kitchens, must be disposed of properly. The harmless disposal of these animal carcasses and waste is an important part of animal disease control and public health care. Only through effective treatment is it possible to render harmless recognized or unrecognized pathogens of diseases in animal carcasses or their parts. Therefore, dead animals and certain animal parts, e.g. from slaughtering, must be properly disposed of in a specialized plant. Kitchen and catering waste from restaurants and canteen kitchens containing animal parts (e.g. meat scraps, sausage) are also subject to statutory disposal.

	Under no circumstances should dead pets be disposed of in the organic waste garbage can or compost. If you have your own property and it is not located in a water protection area, you may also bury your pet on your property. The animal's body must be covered by a layer of soil at least 50 cm thick. Have you found a dead pet? If the animal is on your own property, you as the property owner must dispose of the animal. If the animal is in public traffic areas, please contact the local regulatory authority.
