Volltext	Anyone who, as a citizen of the EU, the EEA or Switzerland, wants to temporarily and occasionally exercise a craft subject to approval in Germany without operating a branch here, must report this. A certificate is then issued by the competent authority.
Erforderliche Unterlagen	 Notification of service provision Copy of identity cardor comparable identification document Proof of legal establishment in the Member State of establishment for the pursuit of comparable activities or, in the case of non-regulated professions, in the Member State of establishment Notification of practical professional experience to the competent authority of the country of origin
Voraussetzungen	 the applicant is legally established in the home country for the purpose of carrying out comparable activities in a member state of the EU, the EEA or Switzerland. The exercise of the professional activity in question is linked to a specific professional qualification (regulated) or there is no regulation of access to the profession, but you have completed state-regulated and thus regulated training.
Kosten	Fees are charged in accordance with the scale of fees

Verfahrensablauf	The craft may be practiced immediately after the notification. The professions Chimney sweep Optician Hearing care professional Orthopaedic technician Orthopaedic surgeon Dental technician may not be exercised until the applicant has received from the competent authority: confirmation that the professional qualification is sufficient, or Notification that the professional qualification will not be examined. In the event of a lack of qualification identified during a re-examination, the applicant shall be given the opportunity to take an aptitude test within one month.
