Volltext	<p>If you complete vocational training with a "stretched journeyman's examination" (journeyman's examination in two parts that fall apart in time), you need a separate admission for Part 1.</p> <p>In order to be admitted to Part 1 of the journeyman's examination, you must:</p> <ul style="list-style-type: none"> • who have completed the required period of training prescribed in the training regulations, • have kept evidence of formal qualifications and, if necessary, have passed prescribed intermediate examinations, • register for the exam or be registered by your instructor. <p>In addition, your vocational training relationship must be entered in the apprentice register. This does not apply if the entry is missing for a reason for which neither the apprentice (trainee) nor his legal representative is responsible.</p> <p>The chairman of the examination board decides on admission to the journeyman's examination. If he does not consider the admission requirements to be met, the examination board decides.</p> <p>Under certain circumstances, e.g. in the case of a shortened apprenticeship period, it may be the case that both parts of the journeyman's examination are carried out together at the end of the training period.</p>
