| Volltext                      | <p>If you wish to import vertebrate animals from third countries (non-EU states) in order to use them in animal experiments or their organs or tissues for scientific or non-scientific purposes, you must apply for an import permit. A permit is not required for farm animals and fish (except zebrafish). Farm animals include horses, cattle, pigs, sheep, goats, chickens, pigeons, turkeys, ducks and geese.</p> <p>The importer is the person who applies for a corresponding permit from the competent authority. Responsibility is determined by the applicant's registered office. If the applicant is not domiciled in Germany, the domestic place of destination (place of intended use) is decisive for determining the competent authority.</p> |

| Verfahrensablauf  | <p>You can submit the application for authorization to import vertebrate animals from third countries for experimental purposes in paper form or online.</p> <ul style="list-style-type: none"> <li>• You provide the necessary information and submit the required documents.</li> <li>• The Lower Saxony State Office for Consumer Protection and Food Safety will check the application.</li> <li>• You will receive a notification which, if the test result is positive, authorizes you to import vertebrate animals from third countries for experimental purposes.</li> <li>• You will be informed of the administrative fee to be paid.</li> </ul> <p>If you wish to submit the application online:</p> <ul style="list-style-type: none"> <li>• Log in to the Lower Saxony administration portal via the Elster company account.</li> <li>• If necessary, submit electronic copies (scans) or digital copies of the required documents.</li> </ul> |
