Volltext	<p>After the death of a trader, the trader may be</p> <ul style="list-style-type: none"> • of the surviving spouse or partner • of the minor heirs during the period of minority • the administrator of the estate, the administrator of the estate or the executor of the will <p>as a rule, are only operated by deputies qualified in accordance with § 45 of the Industrial Code (GewO). After this period has expired, you must appoint a qualified deputy.
