Teaser	If the business license (subject to licensing) has been revoked, the competent authority may allow the business to be continued by a deputy upon application.
Volltext	Following a trade ban, the competent authority may, upon request, authorise the continuation of the business by a deputy person who ensures the proper management of the business. The permit must be applied for.

Frist	There are no deadlines to be observed. However, the authorisation must be obtained before the deputy can be taken up. It is therefore advisable to submit the necessary application as early as possible.

Hinweise	Prior to authorisation, special supervisory authorities may be consulted for the activity, as well as the Chamber of Commerce and Industry or the Chamber of Crafts and, in the case of a trade prohibition against a cooperative, the auditing association to which the cooperative belongs. If the competent authority and the authority that ordered the prohibition are not identical, the prohibition authority should also be consulted in advance.
