Volltext	The keeping of a dog is to be deregistered in the case of: • Abandonment of dog ownership • Submission of the dog • Death of the dog • Loss of the dog • Departure of the dog owner The deregistration as well as the return of the dog tax stamp takes place at the competent authority. At the same time, it is necessary to deregister from the central dog register .
