Volltext	Since a new identification card in credit card format has been introduced since 01.01.2013, an extension of severely disabled passes may no longer be technically possible. When the validity expires, the severely disabled person's pass must be re-applied for.

Frist	The competent authority will automatically write to you 6 to 8 weeks before the expiry of the validity and ask you to apply again.
