Teaser	Have you acquired a professional qualification as a curative education nurse abroad? Then you can apply for recognition of this qualification in Germany under certain conditions.
Volltext	<p>If you want to work as a curative education nurse in Germany, the equivalence of your training with the local training "State-recognized curative education nurse" must be established. This is done by the competent authority.</p> <p>State-approved curative education nurses have the ability to independently and autonomously accompany, care for and care for people whose personal and social identity and integration is impeded by impairments or disabilities and to promote their personal development, education, socialization and rehabilitation. The target group of this occupational group consists in particular of people whose personal and social identity and integration is made more difficult by impairments or disabilities.</p>
Erforderliche Unterlagen	1. Completed application form

2. Hand-signed tabular presentation of your educational and professional background (curriculum vitae) in German,
3. Copy of the school leaving certificate in German,
4. Copies of training certificates in the original language and as a German translation:
 1. Final documents (e.g. diploma), including attachments if applicable, in the original language and as a German translation
 2. Proof of training content (subject table, explanations and curricular requirements, if applicable, etc.) in the original language and as a German translation
 3. Certificate from the competent authority that you are directly authorized to practice the profession in the country of training in the original language and as a German translation.
 5. Copies of evidence of relevant professional experience in Germany or abroad in the form of job references/work books in the original language and as a German translation. The evidence should provide information about the activities and the scope of activities.
 6. Proof of identity (identity card, passport or residence permit)

Translations in German are also required for documents in languages other than German. The translations must be prepared or at least certified by a translator publicly appointed/sworn in Germany.

English-language certificates do not need to be translated.

The Regional State Office for Schools and Education reserves the right to request officially certified copies of the above-mentioned documents.

Voraussetzungen	<p>The following requirements must be met for the professional qualification obtained abroad to be recognized:</p> <ul style="list-style-type: none"> • the professional qualification obtained entitles the holder to exercise professional activities comparable to the profession of a curative education nurse in the country in which it was obtained **, and** • there are no significant differences between the professional qualification obtained in the country of origin and the corresponding professional training in Lower Saxony.
Kosten	<p>Gebühr: 100€ - 250€ A fee of 100 to 250 euros is charged for the recognition procedure.</p> <p>In addition, you must expect further costs when carrying out the recognition procedure (e.g. fees for translations and certifications).</p>
Verfahrensablauf	<p>For recognition purposes, the Regional State Office for Schools and Education Lüneburg will check on the basis of your certificates whether and to what extent your foreign qualification corresponds to a German qualification for the profession of curative education nurse. This assessment is based on defined formal criteria, such as the content, technical focus and duration of the training. Your relevant professional experience is also taken into account, as are other relevant qualifications. The decision on the application is made in writing.</p>

If there are significant differences, a compensation measure (adaptation period or aptitude test) is required before the professional qualification acquired abroad can be recognized. The scope of the compensation measure is determined by the Regional State Office for Schools and Education Lüneburg in a notification.

Bearbeitungsdauer

The processing time is generally up to 3 months, provided that the application documents are complete. An extension may be necessary in individual cases. The period for submitting the application begins with the confirmation from the responsible office that the required documents are complete.
