In addition, the consequences of natural disasters or adverse weather conditions are to be reduced.</p>

Area-relevant measures must be discussed in advance with affected property owners.</p> <p>The following projects are funded:</p> <ul style="list-style-type: none"> • new construction and extension of flood protection facilities (especially dikes), • dismantling of dikes for the reclamation of floodplains, • Repair of existing pumping stations,
