Voraussetzungen	The health insurance fund can provide a service for behavioural prevention if it is certified by a health insurance fund or by a third party commissioned to perform this task on its behalf, i.e. quality-checked. Further information can be obtained from your health insurance fund.
Kosten	The course provider and your health insurance company can inform you of the amount of the costs.
Verfahrensablauf	Ask your health insurance company about the procedure. This is different – depending on whether it is a course with your health insurance company or an external course.
