| Volltext                      | <p>The use of the professional title "state-certified food chemist" is regulated in Germany by the individual federal states. This means that taking up or practicing this profession is subject to the possession of certain qualifications by legal regulations of the respective federal state.</p> <p>This means that you can only work in the public sector with the professional title "state-certified food chemist", for example, if your qualification corresponds to the German qualification "state-certified food chemist".</p> <p>Did you earn your degree abroad? Then you can have the equivalence of your degree with the German degree checked. If you want to practice this profession in Germany, the equivalence of your foreign professional qualification with the German reference occupation must be determined by the competent authority.</p> <p>The competent authority will check whether there are</p> |

If you pass the aptitude test, you will receive recognition and may use the professional title "State-certified food chemist".</p>   |
| Bearbeitungsdauer            | The duration of the processing depends on the individual case. In general, the procedure should be completed within 4 months of receipt of the complete documents.  |

| Hinweise                     | <p>Food chemists investigate and evaluate the chemical composition of foods and commodities as well as the interactions of their ingredients.
