| Teaser | You can have your residence permit extended for the recognition of professional qualifications on the basis of an agreement by the Federal Employment Agency , if you meet certain requirements for this. |
| Volltext | You can apply for an extension of your residence permit if the procedure for the recognition of your foreign professional qualification is still ongoing. The recognition procedure covers the period from the submission of the application to the issuance of a recognition notice concluding the procedure by the competent recognition office. This includes the implementation of qualification measures and subsequent examinations that are required for the determination of equivalence or the obtaining of the professional practice permit. |

Sachverhalt

In case of extension, your residence permit will be limited again. The residence permit for the recognition of professional qualification based on an agreement of the Federal Employment Agency will be extended by one year at a time up to a maximum of three years. After three years, if you have successfully completed the recognition procedure, you can obtain a residence permit to look for a job for one year or a residence permit for another purpose of stay (e.g. to study, to complete vocational training or to pursue employment as a skilled worker).

The Federal Employment Agency must again approve the pursuit of employment in the desired occupational field. The approval is granted for a limited period of one year. It can be granted if you can prove that you are still pursuing the recognition procedure.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

Erforderliche Unterlagen

- Passport or passport replacement
 - Current biometric photo
 - Existing residence permit
 - Proof of livelihood (e.g. blocked account at a bank)
 - Proof of your health insurance
 - Employment contract
 - Rental contract
 - Proof of the recognition procedure (e.g. initial notification from the recognizing body or certificate of attendance for a qualification measure)

Voraussetzungen

- You have a recognized and valid passport or passport replacement as well as the valid residence permit for the recognition of professional qualification based on an agreement of the Federal Employment Agency according to § 16d paragraph 4 Residence Act.
 - The period of validity of your residence permit will expire in the near future.
 - You are pursuing the procedure for determining the equivalence of your foreign professional qualification or, if necessary, for issuing the professional practice permit at the competent recognition office in Germany.

Sachverhalt

- The Federal Employment Agency has approved the pursuit of employment in the desired occupational field.

As a rule, the approval is obtained by the Foreigners' Registration Office.

- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- Your livelihood is secured.

Kosten

- Extension of the residence permit for the recognition of professional qualification based on an agreement of the Federal Employment Agency
 - for a further stay of up to three months: EUR 96
 - for a further stay of more than three months: EUR 93
- Under certain conditions, a fee reduction or fee exemption may be considered.

Verfahrensablauf

The extension of your residence permit must be applied for at the aliens' registration office responsible for your place of residence.

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.
 - If the application is only possible in person, arrange an appointment with the Aliens' Registration Office.
 - During the appointment, your application will be received and your supporting documents will be checked (please bring them to the appointment). For the issuance of the electronic residence permit (eAT) your fingerprints will be taken.
 - In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office. During the appointment, your supporting documents will be checked (please bring them to the appointment) and your fingerprints will be taken for the issuance of the eAT- card.
 - If your application is approved, the Aliens' Registration Office will arrange for the eAT card to be produced.
 - After about six to eight weeks you can pick up your

- Residence permit for the purpose of training
Extension for recognition of professional qualification based on an agreement of the Federal Employment Agency
- Residence permit for recognition of professional qualification on the basis of an agreement of the Federal Employment Agency can be extended if its period of validity expires in the near future but the recognition procedure has not yet been completed.
- The Federal Employment Agency must again approve the pursuit of employment in the intended occupational field. Renewed approval may be granted for one year if the foreign worker continues to pursue the procedure for recognition of the foreign professional qualification.
- The extension must be applied for no later than eight weeks before the expiry of the time limit.
- An extension of the residence permit is only possible if the prerequisites that existed when the permit was first issued continue to exist.
- In the case of an extension, the residence permit is limited again. It is extended by one year at a time up to a maximum of three years.
- The extension is excluded if the extension was
