Teaser	If you cannot be issued a death certificate after reporting a death due to missing data, you can have the death report certified.
Volltext	If you cannot be issued a death certificate after notification of a death due to missing data or evidence, you can have the death report certified. This certificate serves as proof that you have complied with your duty to notify. With the certificate you can prove the proper notification of the death. The report is a prerequisite for the burial of the deceased person.

Voraussetzungen	- You must report the death to the registry office in whose district the death occurred. - The certification of the death must be postponed by the competent registry office due to missing information or evidence. - Only the person who reported the death can apply for the certificate
Kosten	Gebühr: 15€
Verfahrensablauf	- Submit the application in writing or orally to the competent registry office. - The registry office will check your details and, if necessary, issue the certificate. - The registry office will send you the certificate of notification by post, unless a personal collection has been arranged.

Rechtsbehelf	If the registry office rejects your application for a certificate of notification of death, you can apply to the competent court to order the registry office to issue you with the certificate.
Kurztext	• Certificate is issued if data or documents for the certification of the death and issuance of the death certificate are still missing • Application for the issue of the certificate possible orally or in writing • 15€ • competent authority: competent registry office to which you have made the death notification.
