Teaser	If you run a non-profit organization or work for a social service, you can apply for a parking permit. With this you can park for the duration of your work assignment in certain areas.
Volltext	Vehicles belonging to a non-profit institution or social service may obtain a parking permit from the competent authority. This may, for example, entitle the holder to free parking in restricted parking zones, in resident parking zones or in parking space management zones (parking spaces with parking meters or parking ticket machines). As a rule, the exemption only applies to certain individual activities of the non-profit institution or social service. Note the exact content of the exemption. When using the exemption, other persons in particular must not be endangered or hindered.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must present a copy of the vehicle registration document.

Modul	Sachverhalt
Voraussetzungen	The competent authority shall examine the application for the parking card. There is no entitlement on the part of the applicant.
Kosten	The amount of the fee varies depending on the number of vehicles, the period of validity of the parking permit and its scope.
Verfahrensablauf	You must submit an application for the exemption. How the application can be made varies from authority to authority. The authority will then examine your application and, if necessary, grant the exemption.
