| Volltext                      | Vehicles belonging to a craft business or a care service company may obtain a parking permit from the competent authority. This may, for example, entitle the holder to free parking in restricted parking zones, in resident parking zones or in parking space management zones (parking spaces with parking meters or parking ticket machines). The exemption applies only to certain individual activities of the company.<br>Note the exact content of the exemption. When using the exemption, other persons in particular must not be endangered or hindered. |
| Erforderliche Unterlagen      | The documents to be submitted vary from authority to authority.
