Teaser	Have you had your identity card stolen? Then you must report this. In addition, you must apply for a new identity card if you are over 16 and do not have a valid passport document.
Volltext	<p>You can report the theft of your identity card to:</p> <ul style="list-style-type: none"> • any identity card authority, usually the local citizens' registration office, or • any police station <p>You must also apply for a new identity card if you are over 16 and do not have a valid passport document, i.e. a passport or temporary passport. You can do this at the Bürgeramt at your main place of residence. If you do not apply for your new identity card at your main residence, you need an important reason. In addition, a surcharge of EUR 13.00 will be added to the fee. If you contact your chosen Bürgeramt beforehand, you can find out whether and to what extent the Bürgeramt recognises your reason.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • biometric passport photo: The photo must be <ul style="list-style-type: none"> • be up-to-date and • meet the requirements for photos for electronic ID cards. • if available and not yet cancelled: old passport or children's passport (valid or already expired) • if no valid passport or children's passport available: birth certificate or marriage certificate

	<ul style="list-style-type: none"> • if available: police report of loss • for children under 16 years of age: if necessary, a declaration of consent from the custodial parent who is not present • in case of only one legal guardian additionally the proof of custody
Voraussetzungen	<p>The obligation to apply for an identity card applies to you if you</p> <ul style="list-style-type: none"> • have German citizenship • have reached the age of 16, • are registered in Germany • do not have a valid passport document, i.e. passport or temporary passport. <p>For the application outside your main residence:</p> <ul style="list-style-type: none"> • You must be able to show an important reason why you are not applying for the identity card at the identity card authority that is responsible for your main place of residence. • Exception: The temporary identity card cannot be applied for abroad.
Kosten	<p>Gebühr: 10€ for the temporary identity card</p> <p>Gebühr: 22,80€ for applicants under 24 years of age</p> <p>Gebühr: 37€ for applicants aged 24 and over</p> <p>Fee reductions or exemptions are possible for those in need. This is at the discretion of the identity card authority.</p> <p>Zuschlag: 13€ Surcharge for applications submitted outside working hours or not at the main residence</p> <p>Zuschlag: 30€ Surcharge for submitting an application to any citizens' registration office by Germans residing abroad</p>
Verfahrensablauf	<p>To apply for a new identity card after theft, proceed as follows:</p>

	<ul style="list-style-type: none"> • Report the theft to an identity card authority, usually the citizens' registration office, or to the police. You can report the theft informally in writing or in person. • If you want to apply for a new identity card at the same time at the Bürgeramt, you must do this in person and bring the necessary documents with you. • When you apply, your Bürgeramt will inform you when you can collect your identity card. • Your identity card is produced centrally by Bundesdruckerei GmbH. • You can make an appointment to collect your identity card online, by e-mail or by telephone at many Bürgerämter. You can find out which options are offered by your local citizens' registration office, for example, on its website.
