At your request, the competent Chamber of Tax Consultants will appoint the general representative for you. The competent Chamber of Tax Consultants can arrange for the appointment of a general representative ex officio if you have failed to appoint a general representative or to apply for the appointment of a general representative. The representative must be a tax consultant or tax agent.
