Volltext	<p>If you wish to employ a pregnant or breastfeeding woman between 8 p.m. and 10 p.m., you must obtain permission to do so.</p> <p>The supervisory authority may temporarily prohibit you from employing the pregnant or breastfeeding woman during this period in order to protect the health of the woman or her child.</p> <p>If the supervisory authority does not temporarily prohibit employment, you may employ the woman between 8 pm and 10 pm.</p> <p>If your application is not rejected within six weeks of receipt of the complete application, the permit is deemed to have been granted (fictitious permit)</p> <p>No approval is required in the following case:</p> <p>The training center may allow pregnant and</p>

Kosten	<p>In Lower Saxony, the General Fee Schedule is the basis for charging fees. The fees are charged on a time and material basis, but at least €100. Please contact your local trade supervisory office/LBEG for information on the processing fees incurred.</p> <p>The exact costs will be determined after the permit has been issued.</p>

- Describe your request informally or use the form.
- Send your application to the local trade supervisory office/LBEG by post or email, including the required documents and evidence.
- If the documents or information required for processing are incomplete, you will be contacted immediately by the processing department.
- The Trade Supervisory Office/LBEG will check the documents.
- Your application is considered approved if you do not receive a rejection within 6 weeks.
- If the requirements for approval are not met, you will receive a rejection.
- The Trade Supervisory Office/LBEG can also issue you with a provisional rejection,
- In the event of a rejection, you will receive a notice of rejection. You will not receive a notice of approval.
- The notification of costs will be sent to you once the procedure has been completed.

If you would like to apply for approval online, you must complete the following steps:

- You log in to the online service and use it to create your application. Attach the required documents to the application.
- The responsibility is automatically determined and the application is automatically sent to the competent authority after processing.
- The next steps are the same as the written application
