Teaser	The burning of small fireworks requires an exemption outside the year.
Volltext	On 31/12 and 1/1 of a year, persons who are 18 years old are allowed to burn pyrotechnic articles of category F2 without special official permission. For the rest of the year, this is only permitted to holders of an explosives permit or a certificate of competency. The competent authority may grant exemptions from this. It is at the discretion of the municipalities whether exemptions are granted in principle and to what extent, as this is an optional provision. If the municipalities allow exceptions to the general ban on burning, this is only possible for justified reasons. The application must then be submitted to the municipality responsible for the place of burning. The specific information required must be considered on a case-by-case basis, depending on the location, e.g. proximity to fire-prone objects.
